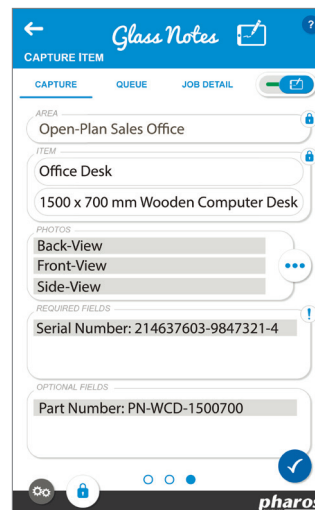

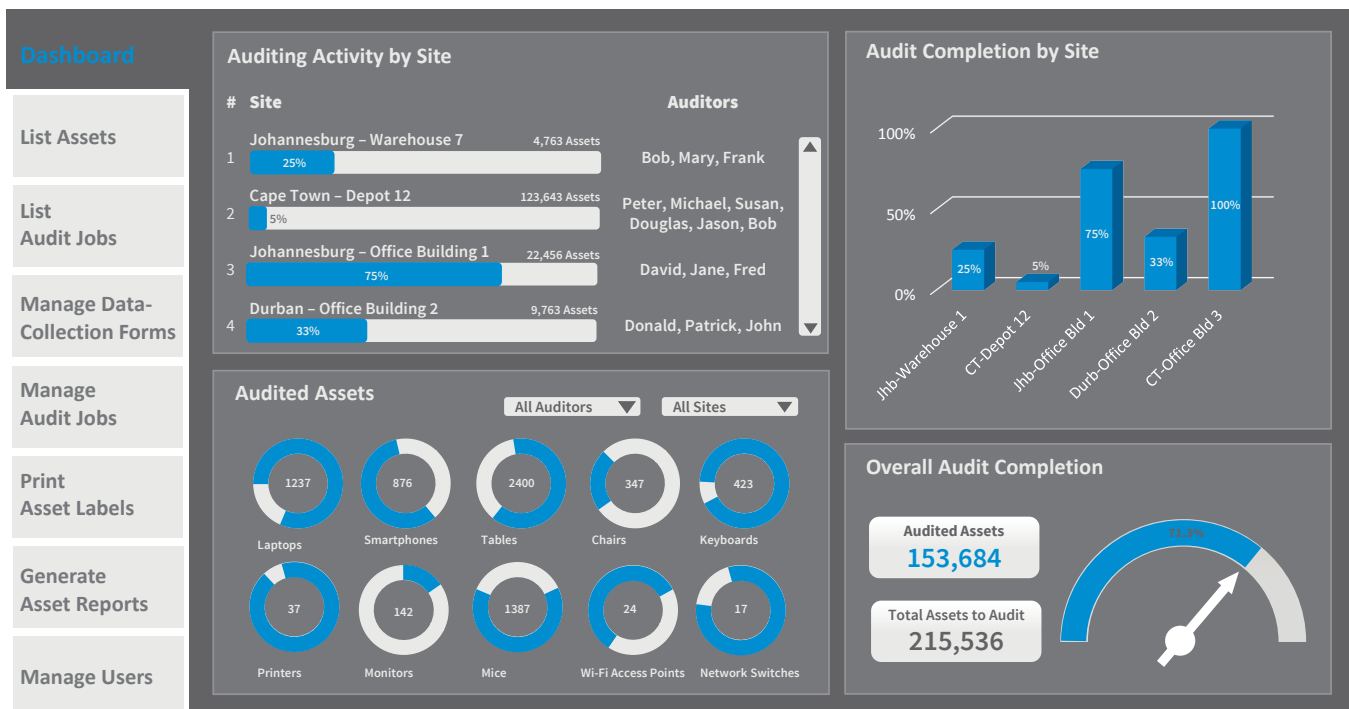
Glass Notes Mobile App: (left)
